The tracking test site will be located in Section 3 of the ranch, with the gate entrance between milepost markers 105 and 106. When coming from Lincoln, the test site is on the left-hand side of the highway; from Great Falls it is on the right-hand side.

Entry fees will not be refunded in the event a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Test Committee, or because it has been entered incorrectly.

Dogs shall be on lead at all times.

Please review Chapter 1, Sec. 16, of the Tracking Regulations

Entries must be made on an official American Kennel Club entry form that includes the Agreement. Do NOT send entries by any method requiring a signature for delivery.

ALL CANCELLATIONS of entries must be made in writing to the Test Secretary and received prior to the stated date and time of closing entries.

I (we) waive any and all claims and causes of action that I (we) might otherwise have against the AKC and any AKC approved judge, judging at this trial, under AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this Tracking Trial has the right to refuse this entry for cause which the club shall deem to be sufficient.
